A) NE/22/01187/FUL – INSTALLATION OF 2.4M GREEN V MESH FENCING AND CANTILEVER AUTOMATED GATE AT FRONTIER CENTRE, ADDINGTON ROAD, IRTHLINGBOROUGH

B) NE/22/01429/FUL – FIRST FLOOR SIDE EXTENSION AND GROUND FLOOR STORE TO BE REBUILT IN BLOCKWORK AT 280 ADDINGTON ROAD, IRTHLINGBOROUGH

Members noted no objections had been raised by the neighbours and didn't consider the application would have an impact on the neighbouring properties.

However, they were concerned about the wording rebuilding of the ground floor store in blockwork. They wished it to be recorded that they would like to see the Ground floor store finished to match the rest of the house and street scene.
